## Tasmanian State Election – 15 March 2014

Shelter Tas is working hard to alert candidates to affordable housing and homelessness issues throughout the election campaign. We have been reiterating some of the key points from our <a href="Budget Submission">Budget Submission</a> and asking candidates to commit to measures to:

- Revitalise Social Housing
- Combat Homelessness
- Maximise Affordable Housing.

In addition, we have contacted candidates, calling on the major parties to commit to **Shelter Tas' 7 election priorities** and demonstrate a commitment to lobby the Federal Government to continue the National Partnership Agreement on Homelessness (NPAH), which is due to expire in June 2014 and currently funds many of our vital support services and supported accommodation facilities.
